It will be held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland (MI), Appendix 35 MI Yearbook, these supplementary regulations and any final instructions issued before the start of the event.
- The entry fee is €195 which includes IRDS/BRDS insurance premium at the standard rate and €30 (per crew) competitors personal accident insurance (less a deduction of €7 per person for those aged 16/17). The entry fee also includes lunch at the hotel.
- Entry forms must be fully completed and accompanied by a cheque dated not later than 12th August. Cheques should be made payable to County Monaghan Motor Club.

- Entries are limited to 70 starters.
- Cars will start at one minute intervals, except where directed otherwise by the organisers.

CLASSES

The entry will be divided into six classes, as follows:

- a1) **Cars built to Endurance specification up to 1000cc**
- a2) **Cars built to Endurance specification from 1001 to 1400cc**
- b) **Navigation Trial cars up to 1400cc**
- c) **Navigation Trial cars from 1401 to 2000cc**
- d) **Front Wheel Drive Retro type cars (retro cars as defined in appendix 33)**
- e) **Rear Wheel Drive Retro type cars (retro cars as defined in appendix 33)**

INDEMNITIES, DECLARATIONS & UNDERTAKING BY ENTRANTS, DRIVERS AND PASSENGERS

(a) I have read the supplementary regulations issued for this event and agree to be bound by them and by the General Competition Rules and Regulations of MI including the guidelines and regulations contained in Motorsport Ireland's Code of Conduct for Children's Sport. In consideration of the acceptance of this entry or of my being permitted to take part in this event I agree to save harmless and keep indemnified the CMMC Limited, Irish Automobile Club Ltd. t/a Royal Irish Automobile Club, Irish Motorsport Federation Ltd. t/a Motorsport Ireland and their respective officials, servants, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s) (as the case may be) howsoever caused arising out of or in connection with this entry or my taking part in this event and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents. Furthermore, in respect of any parts of this event on ground where Third Party Insurance is not required by law, this Agreement shall in addition to the parties named above extend to all and any other competitor(s) and their servants and agents and to all actions, claims, costs, expenses and demands in respect of loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s).
