The event is organised and promoted by The CMMC Ltd., hereinafter called the promoters. It will be held under the International Sporting Code of the FIA, the General Competition Rules of Motorsport Ireland (MI), Appendix 35 MI Yearbook, these supplementary regulations and any final instructions issued before the start of the event.

The entry fee is €230 which includes IRDS/BRDS insurance premium at the standard rate and €30 (per crew) competitors personal accident insurance (less a deduction of €7 per person for those aged 16/17).

Entry forms must be fully completed and accompanied by a cheque dated not later than 15th August 2019.

Cheques must be made payable to The CMMC Limited.

Entries are limited to 70 starters. /Cars will start at one minute intervals, except where directed otherwise by the organisers.

CLASSES

The entry will be divided into seven classes, as follows:

A1 Cars built to Endurance specification up to 1000cc

A2 Cars built to Endurance specification from 1001 to 1400cc

B Navigation Trial cars up to 1400cc as defined in Appendix 33 but excluding 4WD

C Navigation Trial cars from 1401 to 2000cc as defined in Appendix 33 but excluding 4WD

D Front Wheel Drive Retro type cars (retro cars as defined in appendix 33)

E Rear Wheel Drive Retro type cars (retro cars as defined in appendix 33)

F All Sports Cars*

*All MX5 roofs must be of a steel form, either bolted or stitch welded to the bodywork.

Class A2 will be sub-divided into Master, Expert, Semi-Expert, Novice, Beginner.

INDEMNITIES, DECLARATIONS & UNDERTAKING BY ENTRANTS, DRIVERS AND PASSENGERS

(a) I have read the supplementary regulations issued for this event and agree to be bound by them and by the General Competition Rules and Regulations of MI including the guidelines and regulations contained in Motorsport Ireland's Code of Conduct for Children's Sport. In consideration of the acceptance of this entry or of my being permitted to take part in this event I agree to save harmless and keep indemnified The CMMC Limited/Co. Monaghan Motor Club, Irish Automobile Club Ltd. t/a Royal Irish Automobile Club, Irish Motorsport Federation Ltd. t/a Motorsport Ireland and their respective officials, servants, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s) (as the case may be) howsoever caused arising out of or in connection with this entry or my taking part in this event and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents. Furthermore, in respect of any parts of this event on ground where Third Party Insurance is not required by law, this Agreement shall in addition to the parties named above extend to all and any other competitor(s) and their servants and agents and to all actions, claims, costs, expenses and demands in respect of loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s).

Furthermore, the parents and/or guardians of persons under 18 years of age shall grant permission to MI and the Irish Sports Council to carry out tests in accordance with the Irish Anti-Doping Rules (Rule No 139) in the following form: "I/We hereby grant permission to MI and Sport Ireland to carry out tests as set out in Rule No 139 of the GCRs in accordance with the Irish Anti-Doping Rules."

(f) I agree to abide by and be bound by the Motorsport Ireland Social Media Policy of conduct as per Appendix 126 of the current MI Yearbook.
